**COMMUNITY SERVICES**

ESCROW: Wherever “escrow” is referred to in any Community Services Fee Schedule (except as it relates to ISTS pumping of a holding tank) it shall mean that the applicant shall sign an escrow agreement and pay the required escrow before the project/application request commences. Applicants shall pay the actual costs, regardless of the outcome of the project/application request. Actual costs include all County staff time and any outside consultant costs and printing, copying and mailing costs. County Staff time shall be charged at a rate equivalent to 2.1 times salary to cover fringe benefits, overhead and clerical costs. If at any time the actual costs should exceed the escrowed amount, the applicant shall remit additional funds into the escrow fund when requested by the County. If the applicant fails to replenish the escrow as requested, the County may stop reviewing the application until such time as the escrow is replenished. Any remaining funds in the escrow at the conclusion of the project shall be refunded to the applicant when all actual costs are paid and the County administration of the escrow has been completed.

**Time Limitation of Application.** An application for a building permit for any proposed work shall be considered abandoned 180 days after the date of filing, unless the application has been pursued in good faith or a permit has been issued. The building official is authorized to grant one or more extensions of time for additional periods not exceeding 180 days each. The extension shall be requested in writing and justifiable cause demonstrated.

**Expiration.** Every permit issued shall become invalid and be considered expired unless the work authorized by the permit is commenced within 180 days after its issuance, or if the work authorized by the permit is suspended or abandoned for a period of 180 days after the time the work is commenced. The building official may grant, in writing, one or more extensions of time, for periods not exceeding 180 days each. The extension shall be requested in writing and justifiable cause demonstrated.

**Building Permit Fees and Refund Policy.** Once a building permit application is accepted and processed by County staff, the applicant, contractor or property owner (“Applicant”) shall be required to pay a minimum of 20% of the total plan review fee without regard to whether the permit has been issued. The building official shall determine if justifiable cause has been demonstrated and determine the minimum fee to be assessed. If the Applicant chooses to withdraw or cancel a building permit, permit fees will be assessed as follows.

1. Permit Has Not Been Issued: Applicant shall be invoiced for plan review services, processing and all other permit related costs not covered by fees already paid by the Applicant.
2. Permit Has Been Issued: Applicant will be assessed for plan review services, inspections, processing and all other related costs. The remaining funds after all permit related costs have been subtracted will be refunded to the Applicant. If the request for a refund is not made in writing to the building official prior to its expiration or invalidation, none of the fees will be refunded. Fees shall not be refunded on permits abandoned for over 180 days from the filing date, or on permits that have expired for a period of more than 180 days from the date of issuance.

**ORDINANCE NO. 2 - SOLID WASTE MANAGEMENT**

An application fee will be charged for all major amendments as determined by the Department. Application and License fees are nonrefundable. A \$100.00 late fee will be added to the next annual license fee of any facility or hauler that submits their annual report after January 31st. A \$110.00 fee will be assessed for license and Ordinance violations that result in the need for a reinspection and when a company representative fails to notify the inspector in advance to cancel a scheduled inspection. The fee for special inspections or reviews will be **\$110.00 per hour (minimum ½ hour charge)**. Bond amounts shall be adjusted annually, as necessary, based on the following criteria: inflation, changes in operation, and changes in the assumptions or standards used to set the original or subsequent bond amount.

#### F. Additional Permit Related Fees:

1. Property owners who have been referred to the County Attorney's Office for prosecution and charged with failing to replace a failing system may be subject to additional fees requested of the court by the Department to cover administrative costs. In addition, all laboratory and inspection costs incurred shall be billed to the applicant at the time of permit application.

2. Applications for ISTS permits which lack sufficient soils information for approval (due to weather/seasonal soil conditions) but which the ISTS inspector believes contain sufficient information for conditional issuance of a building construction permit shall be allowed to proceed through the permit process with the condition that final ISTS permit approval will not be granted until complete soil information is submitted and approved. The applicant shall pay an additional fee of \$220.00 to cover the cost of follow-up inspections and review.

3. The permit fee for an installation commenced before the Department approves the permit for the site shall be double the current permit fee amount.

4. The applicant shall pay an additional fee equal to 25 percent of the applicable current permit fee when an ISTS/CSTS permit has been issued and the installation has progressed to a point that it can no longer be adequately inspected by the Department because the Department was not given sufficient notice to inspect the system.

5. The permit fee shall be one and one-half (1.5) times the normal permit fee amount when an applicant requests the Department to approve a permit less than six working days between the dates when the complete application is received and ISTS installation will be commenced (subject to staff availability).

6. Permit applicants shall pay an additional fee each time one of the following must be redone:

- 25% of the base permit fee for a design review.
- 25% of the base permit fee for a site inspection.
- 25% of the base permit fee for a soil verification.
- 25% of the base permit fee for significant additional administration.

7. Permit Refund Policy. Permit fees will be refunded for County costs not incurred for both issued permits and for permit applications that were received but never issued. The costs incurred shall be calculated as outlined in a-d below. The maximum refund amount shall be 75% of the base permit fee. Any additional permit related fee assessed over the base permit fee is not refundable, including but not limited to permit renewal and penalty fees.

- 25% of the base permit fee for a design review.
- 25% of the base permit fee for a site inspection.
- 25% of the base permit fee for a soil verification.
- 25% of the base permit fee for administration

8. An ISTS permit is valid for one year after the issuance date. The applicant shall pay an additional fee equal to 25 percent of the applicable current permit fee to renew a permit for one year (50 percent if the permit is renewed for two years). The renewal period begins on the anniversary of the initial issuance date. The permit becomes void three years after the initial issuance date or earlier if the applicant fails to pay an annual renewal fee, as required. The applicant may be subject to additional fees if there are design or location changes from the original permit or if an additional inspection(s) is necessary.

9. An owner or a representative of the owner shall obtain a signed pumping agreement (subject to approval by the Inspector) with an MPCA licensed pumper in order to occupy a new home or other structure before the ISTS



is fully operational (as determined by the Inspector) and pay a fee equal to \$60.00 per month from the date of the proposed occupancy to the forthcoming date of June 30. Additional fees may be assessed for any violation of the pumping agreement.
