Encompasses adoption/guardianship unit, adult mental health, adult protection, chemical dependency, childcare licensing, child protection, child support, children's mental health, developmental disabilities, economic assistance, employment and training, foster care licensing, home and community care, housing and homelessness, mental health center, minor parent services, public health, truancy, and veterans' services.

➤ Scott County Mobile Crisis Response

952-818-3702

Canvas Health's mobile crisis response team responds to mental health crises or emergencies with face-to-face assessment, intervention and stabilization services in the community. Emergencies can be a behavioral, emotional or psychiatric situation needing intervention to reduce the possibility of physical harm. Mobile crisis response staff will also provide necessary safety planning and services to assist in recovery from a crisis.

➤ Economic Assistance

952-496-8686

Determines eligibility and issues benefits for all mandated public assistance programs; this includes cash, Supplemental Nutrition Assistance Program (SNAP), childcare assistance (CCAP), health care, and qualifying for long-term care. May also assist with county burial assistance and fraud investigation.

➤ Employment Assistance

952-496-8686

Offers assistance to eligible adults and seniors seeking employment including training, short-term employment services, and assistance for families with children or on SNAP who are seeking employment. Also assists youth in developing work skills and experience both year-round and in the summers.

➤ Home and Community Care Intake

952-496-8556

Helps people live in the community as independently as possible. Helping the elderly and people with disabilities, and their families, with service planning and getting the help they need. Schedules and completes MNChoices assessments to help individuals make decisions about the supports and services that will help them stay in the community while focusing on their needs and preferences.

➤ Mental Health Center

952-496-8481

The Mental Health Center is an outpatient community mental health clinic which provides diagnostic assessment, therapy and consultation services to the residents of Scott County. Scott County Mental Health Center is a provider for most health plans including Medical Assistance and Medicare. For those without insurance, a sliding fee based on income is available to Scott County residents.

➤ Public Health

Scott County Public Health provides services to promote healthier living for county residents. Public Health staff includes licensed registered nurses and health educators who provide assessment, teaching, support, and referrals to residents of Scott County.

➤ Women Infants and Children

952-496-2125

Assists caregivers and children ages 0-5 years old. Caregivers receive both an eWIC card with funds to purchase specific food items, and regular counseling sessions that give parents and caregivers the support and goal-setting skills they need to help them learn to use those items to create healthy meals.

Child Protection Services

Scott County Child Protection is the public child welfare agency responsible for responding to community concerns about child safety, child well-being and family stability. Our goal is to engage families in a partnership to ensure the safety, permanency, and well-being of their children. This also encompasses a vision of partnering with community members to help support and nurture children and families.

- Call Health and Human Services Central Intake 952-496-8959 to file a report of child abuse or neglect. Reports can be made Monday - Friday 8 a.m. to 4:30 p.m. After hours reports can be made to your local law enforcement.

Adult Protection Services

If you have witnessed or know of a vulnerable adult who has been the victim of physical or mental abuse, neglect, financial exploitation, or unexplained injuries act now to file a complaint or report an incident.

- 9-1-1 should be called before making a MAARC report when reporting abuse which is also a suspected crime, such as physical or sexual assault, or caregiver neglect that results in injury or death, so police can protect the victim, gather evidence and talk to those involved in a timely manner.

Get an Assessment

The MnCHOICES assessment has been developed to help individuals understand their support needs, as well as make decisions about the supports and services that will help them stay in the community.

Paying for Services

Some people pay privately for services or may qualify for funding from Scott County.

During the assessment, our assessors will discuss insurance and other payment sources which could help with the cost of services. Some people are eligible for assistance with part or all of the cost of services through state and federally funded programs administered through Scott County. Depending on your age and disability type, as well as your financial situation, you may qualify for a waiver.

Waiver types include Alternative Care Waiver (AC), Elderly Waiver (EW), Community Access for Disability Inclusion Waiver (CADI), Community Alternative Care Waiver (CAC) and Brain Injury Waiver (BI).

Assistance provided to help maintain a clean, sanitary, and safe environment. Services may include: dumpster rental or refuse disposal, extermination and pest control, general indoor and outdoor home maintenance (e.g. lawn care, snow removal), heavy household chores, or packing the person's belongings.

CDCS has a flexible range of allowable services, supports and/or items that can be tailored to meet a person’s needs.

Services may include delegated nursing tasks, home health aide tasks, help with medication, help with personal needs, supervision, socialization, meals, laundry, housekeeping and memory care, behavioral, mental health, or cognitive supports.

A Medical Assistance benefit that helps people keep or plan for, locate, and move to homes of their own that are not owned, leased, or controlled by disability services providers. A provider is reimbursed for actual time spent helping a person find or keep housing.

There are two ways to find providers:
