Navigate to the Scott County Website: www.scottcountymn.gov

On the right side, click Pay Property Tax

On the Tax Search screen you can search by Parcel Number, Property Address or Mailing Address. Just make sure to change the drop down menu. Click **Search**

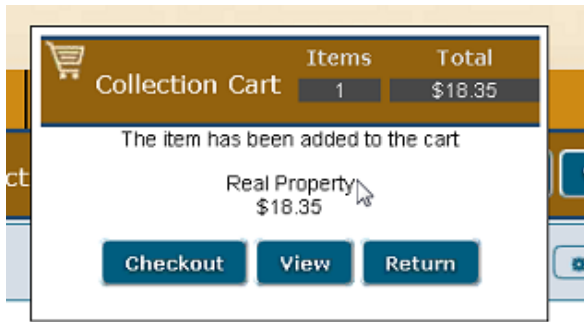

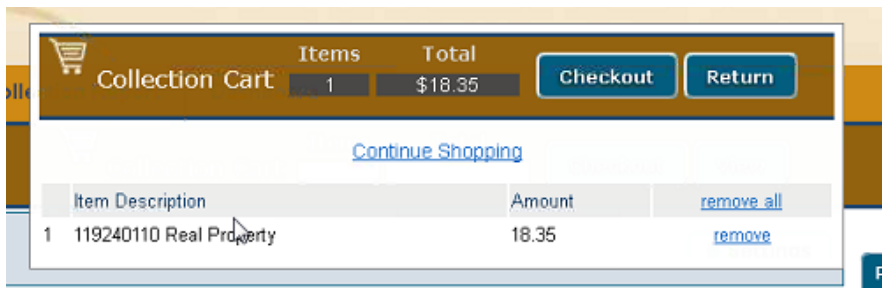

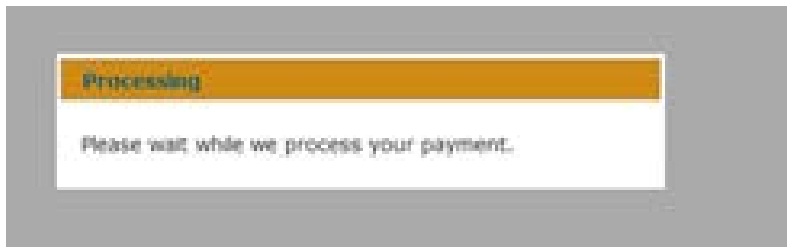
